To whom it may concern:

I am writing you to accuse Enviornmental Systems Research Institute (Jack Dangermond, Laura Dangermond, Bill Derrenbacher (Bill D.), Don Berry, Duane Niemeyer, Cindi Tompkins and Rob Jordan) of crimes against humanity. Millions of people have already died because of ESRI, since June 22, 2006, when our Lord Jesus Christ forbade them to hurt me. "Every 3.6 seconds one person dies of starvation. Usually it is a child under the age of 5." (UNICEF) And, nevertheless, they continue to attack and hinder me. They do not let me serve God. Innocent people continue to die because of them, while they make fun of me.



My Children

“Crimes against humanity are certain acts that are deliberately committed as part of a widespread or systematic attack or individual attack directed against any civilian or an identifiable part of a civilian population. These crimes include inhumane acts that intentionally cause great suffering, or serious injury to body or to mental or physical health, such as the inhumane act of knowingly causing prolonged starvation.”¹

Since 2005, they have made me suffer. After hurting me so much at Environmental Systems Research Institute, where I used to work for them, they tried to kill me to silence me. On June 22, 2006 astroprojected and tried to give me a heart attack, by order of his bosses. But our Lord JesusChrist took pity on me, He saved me from them, and He forbade them to hurt me. But they rebelled against Him and, after they fired me so unjustly, without even having paid me everything that they owed me, they tried to kill me again to prevent me from fulfilling my missions. They tried to assassinate me very cowardly while I slept so that I would not be able to defend myself. But God is always with me and He saved me from them again.

They did not let me work as a scientist, and they did not let me study music either, at Chaffey College, in Rancho Cucamonga, California, so that I could serve God through my art. They harassed me, defamed me, they did not leave me in peace, until finally, on April of 2009, they succeeded in making me sick with a nervous breakdown, and thus I ended up losing the only job that I could find as a tutor, after they fired me so unjustly.



“Every time you want to make fun of me by imitating me because I am always praying to God, remember all the innocents who have died because of you, because you would not let me serve God, and offer your prayers to the Lord for all of those poor little angels.”

I went to the St. Catherine of Siena Church, in Rialto, California, to be with God and have peace of mind. But you did not leave me alone. I was very happy playing music for God and His Holy Mother, and praying for the sick. But ESRI made me sick again in September of

2009. Then they judged me without pity, and they accused me of always having bad thoughts, even though it was they themselves who were responsible for all my ailments. They made me feel unwelcome and I could not go back to my Father's house anymore.

Then, I decided to go to the Mahikari dojo, in Los Angeles, California, to heal all the damage that they caused me and to be able to take care of the sick. I used to travel for over one hour, from my home to the dojo, without any money, so that I could be with the sick and serve God. ESRI knew how much harm they caused me by coming after me. But they did not care, because you only wanted my death. They did not let me serve God in the Mahikari dojo. They made me suffer very much, until I got sick again and was unable to go back, in April of 2010. The ministers who supposedly served God called me a nutcase and made fun of my suffering, instead of helping me like they were supposed to.

Their hatred and their malice followed me everywhere I went, but the Lord gave me the strength to continue fighting for His love. I prayed to God very much for all of my enemies, and I sent His beautiful divine light to everybody who wanted it. I only asked them for a donation for all my effort and sacrifice that I made for all of them. I suffered for all of them so that they could be happy. But, instead of doing our Father's Holy Will, they judged me, they made fun of me, and hacked into my computer to steal from me.



How many more innocents have to die because of you, ESRI?

Therefore, I wrote my beautiful stories to be able to go to my children and give them many gifts to make them very happy, because they did not have anything, and my enemies did not give me one alms and took everything from me. But, as always, they seek to destroy all the beautiful things that I create, in the name of God, for His Holy Glory and Happiness, because they enjoy making me suffer. They hacked into my computer and did not let me write my stories. They stole them and made them public, without my permission, to boycott me. They even considered destroying them to make me suffer, just like they destroyed my brand new computer, which I had just bought with the little money that I had left after they fired me,

infecting it with a virus. But their desire to keep stealing my ideas proved to be stronger. Thus, they made me sick again because of so much evil, and made me stop writing my stories for many years. But the Lord had compassion of the great love that I had for all of my children and all my suffering for seeing them suffer, because my enemies forgot about them. That is why He allowed me to give them all my love and be with them in spirit.

“The national authorities are primarily responsible, first of all, for investigating and prosecuting those most responsible for the commission of mass crimes. The Court will initiate investigations, in accordance with the legal criteria established by the Rome Statute, only when the national authorities have not fulfilled this primary responsibility and in the absence of genuine national procedures.” (Office of the Prosecutor, International Court of Justice)



*“For there is nothing hidden that will not be disclosed,
and nothing concealed that will not be known or brought out into the open.” (Lk 8:17)*

The government of the United States knew the whole truth and denied everything. It knew that my Father declared me innocent and that ESRI rebelled against Him. The World Health Organization and the Center for Disease Control and Prevention do not even report any cases of HIV-cured people, because of the mercy of my Father. “35.4 million [25.0 million - 49.9 million] people have died of AIDS-related diseases since the beginning of the epidemic.” (UNAIDS) Are they perhaps afraid of the truth? Do they not care about the end of this terrible disease that has already claimed the lives of millions of men, women and children? Why, then, do they lie to people? Why do they not respect the Holy Will of God? However, the government has judged me and has defended my enemies. It even threatened me when I sought justice for all their crimes, so that they would let me fulfill my missions in holy peace. It seems as if it does not care about justice, human life, or the planet.

The United States government also denied me the human right to work and earn an honest living by denying me justice for all the crimes that my enemies committed against me,

and allowing them to continue to harass me, defame me and try to kill me with absolute impunity, while I tried to serve my Father and fulfill His Holy Will. That is why I became seriously ill in 2009 and had no other option than to apply for Social Security Disability because I was dying from all the damage that they were doing to me. Still, it has done nothing but judge me, while I continue fighting to survive and serve God. If the world keeps quiet, the stones will cry out!

Environmental Systems Research Institute is guilty of crimes against humanity. Our Lord Jesus Christ saved my life when they tried to kill me, on June 22, 2006, and forbade them to hurt me. But they rebelled against Him and they tried to kill me again to prevent me from fulfilling my missions, and so that nobody would find out that they are murderers. Since they could not kill me because my Father is always with me, protecting me, they have harassed and defamed me all this time, with absolute impunity, dragging many souls to perdition. They do not care about the suffering of the innocent, because the Lord condemned them to the fire of hell. They do not care that millions of people are already died because of them, because they did not let me serve God, and they continue to attack me to make me suffer and prevent me from fulfilling my missions. Innocent people continue to die because of them, while they make fun of me.

Communications may be addressed to the *Office of the Prosecutor, Information & Evidence Unit, Post Office Box 19519, 2500 CM The Hague, The Netherlands*, or sent by email to otp.informationdesk@icc-cpi.int, or sent by facsimile to +31 70 515 8555.

Communications should be written in one of the working languages of the Court, i.e. English or French, or if that is not possible, then in one of the other official languages, i.e. Arabic, Chinese, Russian or Spanish. It is preferable for communications to contain as much detailed information as possible.

Please be aware that the submission of information does not automatically trigger an investigation. In accordance with the Rome Statute, the Office of the Prosecutor must analyse all information submitted in order to determine whether the rigorous criteria of the Statute are satisfied. As you may know, the International Criminal Court has a carefully defined jurisdiction and mandate. We are pleased to provide supplementary information below summarizing the main aspects of the Court's jurisdiction.

Once a decision is taken whether or not there is a reasonable basis to proceed with an investigation, the Office will promptly inform the senders of relevant communications, along with reasons for the decision. The Office will protect the confidentiality of all information submitted.

SUPPLEMENTARY INFORMATION CONCERNING
THE JURISDICTION OF THE INTERNATIONAL CRIMINAL COURT

As you may know, the International Criminal Court (“the ICC” or “the Court”) is governed by the Rome Statute, which entrusts the Court with a very specific and carefully defined jurisdiction and mandate.

Regarding **subject matter** jurisdiction: A fundamental feature of the Rome Statute is that the Court may only exercise jurisdiction over persons for the most serious crimes of concern to the international community as a whole, namely *genocide*, *crimes against humanity* and *war crimes*, as defined in Articles 6 to 8 of the Statute. At this time, the Court cannot exercise jurisdiction over the crime of aggression until the Assembly of States Parties adopts a definition of the crime and the conditions for jurisdiction and amends the Rome Statute accordingly (Article 5(2)).

Regarding **temporal** jurisdiction: Under Article 11 of the Statute, the Court may only exercise jurisdiction over crimes committed *after 1 July 2002*, the date of entry into force of the Statute. This means that allegations of incidents occurring prior to this date fall outside the Court’s jurisdiction.

Regarding **personal/territorial** jurisdiction: Under Articles 12 and 13 of the Statute, the Court may only exercise jurisdiction over international crimes *if one or more of the following criteria are met*: (i) its jurisdiction has been accepted by the State on the territory of which the crime was committed, (ii) its jurisdiction has been accepted by the State of which the person accused is a national, or (iii) the situation is referred to the Prosecutor by the UN Security Council acting under Chapter VII of the UN Charter. For a complete list of countries that have ratified the Statute and thereby accepted the jurisdiction of the Court, please visit the Assembly of State Parties website:

Even where all of these criteria are satisfied, the Office must also assess other factors, such as the gravity of the situation, whether national judicial systems are investigating and prosecuting the alleged crimes, and the interests of justice.

Given the defined jurisdiction of the Court as well as the need to focus its limited resources on the gravest situations, many serious allegations will be beyond the reach of this institution to address.

Please rest assured that if you do choose to submit information to the Office of the Prosecutor, your communication will be analysed in accordance with the Statute. In light of the complex issues that must be addressed, analysis can take some time. Once a decision is reached, you will receive a response along with reasons for the decision.

On behalf of the Prosecutor, I thank you for your communication received 05/09/2018, as well as any subsequent related information.

As you may know, the International Criminal Court ("the ICC" or "the Court") is governed by the Rome Statute, which entrusts the Court with a very specific and carefully defined jurisdiction and mandate. A fundamental feature of the Rome Statute is that the Court may only exercise jurisdiction over persons for the most serious crimes of concern to the international community as a whole, namely genocide, crimes against humanity and war crimes, as defined in the Rome Statute (Articles 6 to 8). The Court may only exercise jurisdiction over crimes committed on or after 1 July 2002 (Article 11). In addition, the Court may only exercise jurisdiction over crimes committed on the territory of a State that has accepted the jurisdiction of the Court or by a national of such a State (Article 12), or where the Security Council refers the situation to the Court (Article 13).

Accordingly, I regret to advise you that your communication appears to relate to matters outside the jurisdiction of the Court. The Prosecutor has therefore confirmed that there is not a basis at this time to proceed with further analysis. The information you have submitted will be maintained in our archives, and the decision not to proceed may be reconsidered if new facts or evidence provide a reasonable basis to believe that a crime within the jurisdiction of the Court has been committed.

I hope you will appreciate that with the defined jurisdiction of the Court, many serious allegations will be beyond the reach of this institution to address. I note in this regard that the ICC is designed to complement, not replace national jurisdictions. Thus, if you wish to pursue this matter further, you may consider raising it with other appropriate national or international authorities.

I received your email from April 4, 2019. However, your conclusion that my case relates to matters outside the jurisdiction of the International Criminal Court is wrong. On behalf of the Prosecutor, I thank you for your communication received on 13/04/2019.

I note that your communication concerns matters that are substantially similar in nature to those in a communication you previously submitted to the Office of the Prosecutor. In our response of 04/04/2019 we advised that the matter described in your communication appeared to fall outside the jurisdiction of the International Criminal Court ("the Court"), and the Prosecutor had confirmed that there was not a basis to proceed with further analysis.

The Office of the Prosecutor has carefully examined your latest communication. I regret to advise you that the Prosecutor has confirmed that the communication does not introduce new facts or evidence that would alter the previous determination that there is not a basis to proceed under the Rome Statute. Under the Rome Statute, the Court may only exercise jurisdiction over genocide, crimes against humanity and war crimes, as defined in the Rome Statute (Articles 6 to 8), when committed on or after 1 July 2002 (Article 11). In addition, the Court may only exercise jurisdiction over such crimes committed on the territory of a State that has accepted the jurisdiction of the Court or by a national of such a State (Article 12), or where the Security Council refers the situation to the Court (Article 13). In the light of these requirements, your communication still appears, after careful re-examination, to relate to matters outside the jurisdiction of the Court.

I hope you will appreciate that with the defined jurisdiction of the Court, many serious allegations will be beyond the reach of this institution to address. We are grateful for your continued interest in the International Criminal Court.

On behalf of the Prosecutor, I acknowledge receipt of your communication received on 23/07/2020.

According to our records, you have sent three or more communications to the Office of the Prosecutor dealing with matters which are substantially the same as those already examined by it.

As noted in our previous responses, the matter described in your communications does not appear to fall within the jurisdiction of the International Criminal Court ("the Court"), and the Prosecutor has confirmed that there is not a basis to proceed with further analysis in the absence of new facts or evidence.

The Office has carefully examined your latest communication and has re-confirmed that it does not introduce new facts or evidence altering the conclusion that there is not a basis to proceed under the Statute.

I hope you will understand that the Court is governed by Rome Statute, which provides a very specific and carefully defined jurisdiction and mandate over the most serious crimes of concern to the international community as a whole, under strict conditions specified under the Statute. As a result, many serious allegations will be beyond the reach of this institution to address.

Please understand that, given our carefully defined mandate and limited resources, where a person submits a succession of communications or seeks repeatedly to re-introduce the same matter, the Office is not able to continue further correspondence with that person on subsequent related communications.

Perhaps it just does not care that millions of innocents have already died because of them, and therefore it will not do anything to stop them, while millions more continue to suffer. Since the United States has rebelled against God and has become their accomplice, the Almighty will do me justice.

Fourth Reply from the International Criminal Court – July 13, 2020

I note that your communication concerns matters that are substantially similar in nature to those in a communication you previously submitted to the Office of the Prosecutor. In our response of 4/4/2019 we advised that the matter described in your communication appeared to fall outside the jurisdiction of the International Criminal Court (“the Court”), and the Prosecutor had confirmed that there was not a basis with further analysis.

Fifth Letter to the International Criminal Court – July 22, 2020

You have violated the Rome statute. The International Criminal Court is corrupt and **I have no desire to continue wasting my time with you, as I also explained to you in my last letter, over a year ago (4/12/19). Please abstain from contacting me anymore.** God will do me justice.

The International Criminal Court contacts me a fifth time, after I asked them repeatedly on two occasions, to cease their communication – September 14, 2020

Please understand that, given our carefully defined mandate and limited resources, when a person submits a succession of communications or seeks repeatedly to re-introduce the same matter, the Office is not able to continue further correspondence with that person on subsequent related communications.

I finally had to block the International Criminal Court so that I could focus on serving God (while my enemies continue to attack me, and governments do nothing to stop them) and be able to save many lives. No one can stop the Holy Will of God. He will judge all the nations of the world. “The heavens declare the glory of God, and the sky above proclaims His handiwork.” (Psalm 19:1) “Holy, Holy, Holy is the Lord of hosts; the whole earth is full of His glory!” (Is 6:3) He will do me justice.
