If the Loma Linda University Medical Center lied, and my medical condition is indeed contagious, why has it let me suffer for almost fifteen years, since 2006 or 2007, instead of treating me, so I would not put anybody else in danger? But if it has said the truth from the beginning, based on many examinations and laboratory tests carried out by various professionals, besides my doctor, over the years, what does it accuse me of now, if I have only followed its own instructions for taking care of my skin.
