## **They Hurt Me and Make Fun of my Suffering**

I have decided not to return to the psychiatric clinic of Social Action Community Health System in order to protect my mental health. My enemies, Environmental Systems Research Institute and their accomplices, are always harassing and defaming me to make me sick and make me stop serving God. This time they have followed me to my SACHS clinic to obtain my medical information illegally and continue to hurt me.

In 2006, when I was working for ESRI, I was treated for all the psychological damage that they did to me, for the first time. On that occasion, they falsified my identity to obtain my private medical information. Since then, they have always broken the law to make me suffer, with absolute impunity, because the United States government protects them. When I lost my job because of them, and I had no health insurance, I received medical attention at the San Bernardino Department of Public Health clinic. But in 2012, I suffered from discrimination and stopped seeing my doctor because I did not feel safe. For almost ten years, I have been treated at the SACHS clinic for all the psychological damage that they have caused me, but they do not want me to get better and be healthy. They just want me to suffer because they blame me for having been condemned to hell by God for all their evil.

My doctors at the SACHS clinic did not respect their oath to do no harm. They are always trying to increase the dose of my medication, arguing that I need a stronger dose so that it can be effective. But behind my back, they share my medical information with my enemies who publish it to make fun of all the suffering they have caused me and continue to harm me. Do they really think that by taking more medicine I will forget that my enemies are trying to kill me? Since they could not assassinate me by giving me a heart attack, they try to make me sick mentally (harassing and defaming me) and physically (spitting in my food) so that I die of pain and stop serving God.

Proof of this is how they make fun of me because I supposedly suffer from flatulence. I knew they had access to my medical records, as I had already revealed to you, and I knew that they were trying to hurt me. But, as you well know, I have never been sick. "You've never had any problems." (God the Father) Otherwise, I would have asked my doctor for a referral to see a specialist and I would have asked him for medicine to cure me. Everything was a lie of theirs to make me suffer. Their hearts are full of hatred and evil. "A good man brings good things out of the good stored up in his heart, and an evil man brings evil things out of the evil stored up in his heart. For the mouth speaks what the heart is full of." My enemies are always doing evil and dragging many souls to damnation along with them.

It is interesting how nobody complained about me until they deceived them and poisoned their hearts. They turned even my loved ones against me. I had a friend that I loved very much, more than a friend as a brother. But even he sprayed aerosol on me, as they did in their company, because they convinced him that I smelled bad. I tried to help another friend, who really served my enemies, and he betrayed me by lying to him. I also lost my partner that I loved so much when I told him about all the bad things that they did to me in their company. I suffered very much because of them. But instead of supporting me, he also made fun of me. But their old tricks to hurt me do not work anymore because I

am with God. “Remember that you must never be afraid, because I am always with you, watching over you.” (God the Father) If only they would convince themselves to do good instead of doing evil...

The evil people of ESRI have always hurt me and made fun of my suffering since I worked for them. They harass and defame me and do not leave me in peace. They have made me sick so many times so that I cannot serve God anymore, without caring about all the harm that they do to millions of innocents. Once more, as always, they have succeeded in leaving me without medical care. I can no longer see my psychiatrists in the SACHS clinic because my doctors have broken our confidentiality between doctor and patient, and have revealed my medical information to my enemies, who have used it to try to hurt me. But the truth always comes to light. Good always triumphs against evil.
